## FAIR SHARE/BAND CAMP 2020

Welcome to the Rodriguez Entertainment Unit for the 2020-2021 school year! Band Camp will be held at Rodriguez High School. If you signed up for Symphonic Band, Advanced Symphonic Band, or Pageantry Dance, you are signed up for MARCHING BAND and must attend Band Camp. If you are a member of COLORGUARD you must attend Band Camp. During this crucial 2 weeks, we begin to learn the music and marching band & colorguard skills for the upcoming competition season.

Below are the *mandatory* band camp dates. Every day we are working with the Fairfield-Suisun Unified School District (FSUSD) and will operate under the current district COVID-19 guidelines to ensure the health and safety of all students (see below). Our entire staff will be responsible for ensuring the guidelines are being followed. As we are updated from FSUSD, we will be in communication with you and your family on further logistics of band camp. **Please save these dates as we are hoping we can move forward with a band camp under COVID-19 guidelines.**

### **Mandatory Band Camp Dates**

- July 30th & 31st from 9:00am - 3:00pm (*Colorguard and Drumline members only*)
- August 3rd from 8:30am - 4:30pm (*New REU members and student leaders only*)
- August 4th - August 7th from 8:30am - 4:30pm (*ALL REU Members*)
- August 10th - August 14th from 8:30am - 6:30pm (*ALL REU Members*)

### **Band Participation Packet - 100% COMPLETION IS REQUIRED TO PARTICIPATE**

For your child to attend and participate in band camp, a parent or guardian **must complete the attached packet of forms titled "Band Participation Packet 2020"**. Within this packet, your student will have had to complete a sports physical by their physician.

If you're a **new REU member**, you must: have completed a sports physical by your physician through an in person visit, tele-health visit, or make an appointment for a free sports physical held by NorthBay HealthCare (<https://www.northbay.org/services/orthopedics/Fall-sports-physicals.cfm>.)

If you're a **returning REU member**, you must: have completed a new sports physical OR have your previous school year's physical extended by your physician through an in person visit or a tele-health visit. *To receive a copy of your previous school year's physical, please email Director Scott Miller at [scottm@fsusd.org](mailto:scottm@fsusd.org).*

### **Current COVID-19 Guidelines in Place**

- Prior to entering a facility all hard surfaces will be sanitized.
- Individuals should wash their hands for a minimum of 20 seconds or use hand sanitizer prior to touching hard surfaces in the facility and as often as possible.
- Frequently used items and surfaces shall be disinfected as much as possible.
- Students are encouraged to clean their individual instruments/equipment at the end of each rehearsal.
- All staff and students will be screened daily for symptoms of COVID-19, such as sore throat, cough, shortness of breath, or a fever of 100.4 degrees prior to participating. Our staff will administer temperature checks each day.
- Any person with positive symptoms reported shall not be allowed to participate and will be sent home immediately. They will require written medical clearance to return to events.
- All participating students must bring their own water bottles and are not to share. Water fountains will be used for refilling bottles only.
- Food shall not be shared.
- State and local guidelines for face coverings will be enforced. Plastic shields covering the face are not allowed due to risk of unintended injury.
- Sharing of instruments/equipment shall not be allowed (towels, clothing, shoes, activity-specific equipment).
- Physical contact such as high-fives, fist/chest bumps, and hugs shall not be allowed.
- Rehearsal shall be held outdoors with social distancing enforced when the wearing of masks is not feasible due to the nature of practice being conducted.

### **Cost**

\$400 is due at band camp. The \$400 will be deducted from the total fall season fair share of \$650. Checks should be made out to Rodriguez Music Boosters. Credit and Debit cards will be accepted. There is a 3% added charge to cover PAYPAL credit/debit card fees.

Marching/Guard Shoes are an additional expense - \$35.00/\$40.00

Total cost per Student - \$685/690

Remember working BINGO or becoming the BINGO Coordinator is a great way to help offset some of your student's Fair Share.

**Important Must Haves for Band Camp each day**

- \$400 check made payable to Rodriguez Music Boosters.
- A separate check for any meals that are to be purchased by the student during band camp. A separate lunch order form will indicate the type and cost of each meal.
- Check for Marching Shoes (may be combined with band camp check).
- Face covering (not a plastic shield).
- Hand sanitizer
- Tennis Shoes and socks (required).
- Hat/Visor
- Instrument and supplies needed for your instrument.
- Pencil
- Water Bottle you can refill throughout the day.
- Sunscreen
- "Band Participation Packet 2020" – this is 100% mandatory and students that do not have this completed will not be allowed to participate. Available for download at [rhseu.org](https://rhseu.org)
